Our Telford and Wrekin

The borough which the Safeguarding Adults Board serves is a place of contrasts. Central to the borough is the new town of Telford which was commissioned in 1968, and grew rapidly around existing communities including Wellington, Oakengates, Dawley and Madeley. Along the banks of the River Severn is Ironbridge, the birthplace of the industrial revolution and now a World Heritage site. Outside of our communities, Telford is surrounded by a rural environment which accounts for more than two thirds of the borough's area..

The 2021 Census estimated the population of the borough to be 185,842 people. A quarter (45,504 people) are aged 0 to 19. From the 2011 to 2021 Census, the borough's overall population increased by 19,000 people – an increase of 11% - making it the fastest growing area in the West Midlands. As the population grows it is becoming more diverse and ageing, between 2011 and 2021, the number of people aged 65+ grew by 36% which is twice the regional rate of 18%.








Telford offers exceptional employment and housing opportunities. We also have many schools, beautiful rural retreats, museums, activities, a flourishing shopping centre as well as local hubs, and the additional bonus of excellent commutability to all areas of the United Kingdom with our extensive rail and road networks. However, the Index of Multiple Deprivation shows that there are 18 neighbourhood areas in the borough which are ranked amongst the 10% of the most deprived in England. This may impact upon life experiences of these residents in terms of poorer outcomes with regards to health for example. Such challenges have undoubtedly increased due to the current cost of living crisis. This impact can be evidenced with increased requests for support from adult social care across the borough:

- The number of safeguarding concerns raised in 2023/2024 showed a slight increase for a second year running with 477 logged this year. This is a 7% increase from two years ago.
- During 2023/2024 54% of safeguarding enquiries were to protect females with males being at risk in 46% of cases.
- 2023/2024 saw a 59/41 split between females and males at the centre of concerns respectively.







Who we are

Telford and Wrekin Safeguarding Partnership (TWSP) is a statutory and multi-agency partnership. We are determined to ensure that people rather than policies or processes are at the heart of our work and drive what we do. Telford & Wrekin Council, West Mercia Police and Telford & Wrekin ICS (health partners) have a statutory duty to put in place multi-agency safeguarding arrangements to protect and safeguard adults at risk due to their care and support needs. This responsibility is delivered by the Telford & Wrekin Safeguarding Adults Board which is equally funded, by the three statutory partners

We believe that the voice of Telford and Wrekin people is crucial in understanding how well the Safeguarding Adults Board is meeting their statutory duties and whether services are meeting the needs of Telford people.

Together we hold each other to account and learn through identifying best practice and areas which need development to improve the quality of life of residents within Telford and Wrekin and to ensure continued freedom from harm.

In addition to our local partners Telford and Wrekin Safeguarding Partnership is in regular contact with our counterparts up and down the country. We all proactively share learning and good practice.

What we do

Telford and Wrekin Safeguarding Adults Board has the following core functions within the Care Act 2014:

- To develop and publish a strategic plan. This plan sets out our safeguarding priorities, evidencing what we need to do to achieve these, and how we plan to do it.
- To carry out and publish Safeguarding Adults Reviews (SARs). These reviews help us to identify learning which we then use to implement and embed improvements across the Partnership
- To publish an annual report which details the work we have accomplished over the previous 12 months, the number of Safeguarding Adult Reviews which we have undertaken and the changes that have been implemented as a result. The Safeguarding Adult Board also have a commitment to publish a version of all completed Safeguarding Adult Reviews to aid transparency and maximise learning opportunities.

How we do it

The Safeguarding Adults Board is led by an independent chair appointed by the three statutory partners with the objective of providing independent challenge and scrutiny. As part of our arrangements for external challenge, The Chair presents the Safeguarding Adults Board's annual report to the Health & Wellbeing Board.

To drive delivery of its objectives, the Safeguarding Adults Board has a series of sub-groups as set out below:
